1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

The Institution was started by Bunts alias Shetty Community who hails from Dakshina Kannada District of Coastal Karnataka. Bunts Community predominantly landowners engaged in agriculture & cultivation. Bunts means soldiers or warriors like the Marathas in Maharashtra India. The Bunts Community believes in the adage "LIVE & LET LIVE". They are the Nationalist force working for the upliftment of Culture and the rich heritage of our Nation.

BBA came into being in the year 1982 through the earnest and dedicated efforts of a team of pioneering philanthropists imbued with a sincere sense of mission. The Association was registered under the Societies Registration Act, of 1860, and the Bombay Public Trust Act, of 1950 in the year 1983. BBA's Bunts College of Higher Education (Night College) affiliated to the University of Mumbai has got permission from the Maharashtra government as well as from the University of Mumbai to run the degree courses - B.Com. (Accounting & Finance), BMS (Bachelor of Management Studies) and B.Com. (Bachelor of Commerce) from the academic year (2014-15). BBA Night College will be a boon to the working class who can acquire the degree and at the same time earn and learn which can be the benefit to the student and their families. Most of our people who had come to Mumbai about 30 to 50 years ago were products of night schools and night colleges.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

- 1. Curriculum Planning and Delivery: The institute is affiliated with Mumbai University. The curriculum designed by the affiliating University is strictly followed by the Institution.
- 2. Academic Calendar: As per University guidelines the Institution prepared Academic Calendar and displayed on the notice board, even hosted on the Institution's website every year.
- 3. Continuous Internal Assessment (CIA): The Semester-end examination and continuous internal assessments are done as per directions given by the affiliating University. Internal assessment is done by conducting viz. mid-term tests, project work, technical quizzes, and group discussions.

The Academic Monitoring Committee (AMC) representatives from all disciplines clinch the curriculum and the Academic Calendar given by the University throughout the year. The extension activities are conducted apart from the curriculum. We smoothly follow all activities throughout the semester as a semester pattern education system established by the affiliating University.

Activities conducted beyond the curriculum:

- 1. To develop professional ethics amongst the students, faculties, and non-teaching staff continuous efforts are taken by organizing expert lectures and industry visits which also helps the students to know the gap between academic curriculum and to meet industry requirements.
- 2. The Institute prompts a culture of involving boys and girls in every activity. Gender equality is also maintained amongst faculty members.
- 3. The Institute has arranged a separate session on "Women's Empowerment" to encourage female students to participate in various activities. NIRBHYA BOX/ SAKHI BOX was formed to create a safer environment.
- 4. The Student Council conducts environmental and social awareness activities.

The subjects that include professional ethics, gender, human values, and environmental trends are taught as per the curriculum. Gender equity reports are also posted on the website which has been conducted during the last five years in the institution apart from the curriculum and the link is provided.

Teaching-learning and Evaluation

Participative ILearning: Participative learning is carried out through classroom learning. Faculty members in addition to classroom teaching or sessions are interactive and reciprocal. Also, faculty members used to ask questions during the lecture through quizzes, group discussions, and brainstorming sessions, and students were instructed to respond to the questions.

Assignments: After the completion of one or two modules, faculty members uploaded questions on an understanding level. Assignments were given on each module or the combinations of modules depending on the weightages of modules as mentioned in the syllabus of the University, where COs and POs are mapped.

Analyzing and Problem Solving: Students are made to analyze and solve the problems through brainstorming sessions and case study discussions.

Problem Solving Methodologies: Various industrial problem statements were collected from the field trip and distributed amongst the student group to work on them and to find a better solution.

The mechanism of internal assessment is transparent and robust in terms of frequency, mode, and innovation introduced in the internal evaluation. Periodically the projects undertaken by the students were assessed by the faculties. The students were asked to submit final reports and their observations were monitored by the concerned faculties. The students who had completed their internship were asked to submit a certificate from the concerned firm. Based on the faculty's remarks, the reports of the final mark sheet were processed to the examination cell. If any grievance is found during the internal assessment, then it is taken care of by the Institute head. For the last five years, no grievance has yet been reported.

Once final course outcomes were prepared by faculty members, it was displayed on the Institution's website so that any stakeholder could access it. The program's outcome was also prepared by the Head of the Department and posted on the website. For newly admitted students during the induction program concern faculty members explained to them the course outcomes. The Institute's notice board displayed the course outcomes as well as program outcomes. All efforts were taken by the Institute to focus on Object-Based Education.

Research, Innovations and Extension

The Institution had created an ecosystem for innovation, including awareness about IPR, Research methodology (RM), and Entrepreneurship Development Programs (EDP). The main purpose of conducting such workshops and seminars is to motivate students and faculties in the field of research. This awareness program gives an idea about the procedure and areas where research contribution is expected. Apart from this, our management supports faculties for the research work.

- 1. Workshop and seminars are conducted on outcome-based.
- 2. Expert Lectures were conducted to give ideas about recent trends in research.
- 3. Entrepreneurship programs were conducted to motivate entrepreneurship rather than seeking jobs that can provide employability to others.

The Institute conducted extension activities in the neighborhood community, sensitizing students to social issues. The life learning methodology is adopted by the Institute for the overall development of the students being a socially responsible entity. Extension activities are carried out with the help of the Student Council and

in coordination with NGOs. The main purpose behind it is to get students familiar with issues the common people are facing and find realistic solutions for them. Students worked at ground level and tried to find out problems and solutions on it. This activity improves students' problem-solving skills along with time management skills. The Institution is always in favour of conducting awareness and extension activities for society. In the last five years Institute conducted such kind of events for society. The Institute conducted extension activities in the neighborhood community, sensitizing students to social issues. The life learning methodology is adopted by the Institute for the overall development of the students being a socially responsible entity.

Infrastructure and Learning Resources

The Institute has adequate infrastructure and physical facilities for teaching and learning. Three ICT-enabled classrooms along with a well-equipped conference room are available in the Institute where students can experience interactive classroom experiences. The library is also well equipped with a digital facility where students can access e-resources to impart their knowledge along with a spacious reading room. The Computer Center is along with computers and printers where students can access digital platforms with free Wi-Fi access. The Institution has an ICT-enabled auditorium with adequate facilities for cultural activities. The students can use the auditorium whenever they like to do the practice for any activity. Our students won prizes in the Youth festival at the University level. Indoor sports and game facilities keep students physically healthy and stress-relaxing. A yoga center with a meditation facility boosts mental strength and creates positive vibes.

The library plays an additional important role in our professional Institute. The library is automated using N -List E- resource software as the OPAC system is used for checking the availability of books in the library. The facility of a digital library plays an important role in accessing online resources including e-journals, databases, and e-books. The free internet access provides more flexibility than traditional physical books. Every year fixed budget is sanctioned by the management of the library and purchase is done as mentioned in every year's audited statements. library E-Granthalaya software is also available.

Institute infrastructure viz. classrooms, auditorium, computer center, library is ICT enabled. To that extent, IT facilities including free Wi-Fi facilities are provided to all teaching and non-teaching faculties along with students. This provides anywhere, anytime free Wi-Fi access to all stakeholders. The Bandwidth speed of 50 Mbps provides connectivity to the internet. The Institute has a portable projector and four fixed-installed projectors in classrooms.

Student Support and Progression

The Institution has registered its alumni association under, Thane/ 18/12 /2023. The institution formed Alumni Association for the development of the Institution. This Association conducts regular meetings with a proper agenda. The important roles played by our eminent alumni were Perspective plan and improvement of quality education, providing internships in their firms, providing placement and career guidance, Contributing to Institute events as special guests and brand Ambassadors, and Sponsoring college events.

The Institute conducts Career Guidance Sessions for the students to explore alot of things in this competitive world.

The Institution provided all kinds of support to avail government and non-government scholarships.

The Institution also plays an important role in placement as well as in support of sending students for higher studies.

The Institution provided all kinds of ICT-enabled tools for accessing maximum resources to improve their knowledge. The Institution provided an Internet facility of 50 Mbps speed. Well-equipped computer center is available for access to the students at any time. The Institutional library is open to students at any time where they can access books physically as well as with the help of online resources. The spacious reading room with digital library facility is provided.

Governance, Leadership and Management

The governance of the Institution is constituted by a Management Representative, the Head of the Institute, senior faculty members, the IQAC Co-ordinator, and Alumni Representative. As all stakeholders are involved in this, it is reflective of and in tune with the Mission and Vision of the Institute. The institutional perspective plan is effectively deployed and functioning; Policies are made for academics and all stakeholders; administrative setup as per guidelines given by affiliating University; Appointments are as per the norms of the University and UGC guidelines; Service rule books are maintained; Standard Operating Procedures (SOPs) are well-defined. Moreover, feedback is taken by all stakeholders while drafting the Mission and Vision along with the perspective plan.

The Institution has effective welfare measures for both teaching and non-teaching staff. All members are treated as family members. The Trust supports financially as well as professionally to everyone. For improving educational qualifications and the research work, faculties are supported by all means.

The Institute conducts internal and external financial audits regularly every year. No discrepancy was found from the last five years or from the establishment of the institute and Trust. Institutional strategies for the mobilization of funds and the optimal utilization of resources are predefined. Trust reserved funds can be utilized during disaster management as in covid-19 situations where students were not able to pay any tuition fees, still regular salaries paid by the management. The best example of the optimal utilization of resources infrastructure where floor-wise and in-shift utilization is for the education sector. Any infrastructure development in the future also will be planned from mobilizations of funds.

Mobilization and Optimal Utilization of Resources: The main source of revenue is student fees, Infrastructure Augmentation funds raised by the management, and CSR funding. The objective of the trust is to provide quality education at an affordable cost at the doorsteps of the students, especially a migrated/economically weak sectors, proper utilization of infrastructure and academic facilities.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

To go for the overall development & capacities of the students - moral, physical, ethical, emotional, social & intellectual in an integrated manner. The college is preparing to include Multidisciplinary subjects as per the New Education Policy - 2020. To Understand the problem faced by present students, the college is planning to set up a few short-term & vocational courses. The vision of the college is promoting Value-Based Quality Education hence the college makes efforts to inculcate & imbibe a positive approach among its learners. The college celebrates all the National festivals like Independence Day and Republic Day. It also celebrates religious festivals like Holi, Dandiya, Eid celebration and Ganpati. It observes important days, celebrating the death & birth anniversary of great National leaders like Gandhi, Subhash Chandra Bose & Swami Vivekananda, and imbibes good qualities among the students. We provide MS Office training, English Speaking Course, Time Management and basic technique of marketing. Mentoring students is one of the most important practices of the Institution. The faculties help them to explore the student's hidden talents, how to utilise & channel their energy & give proper direction for their potential.
